Minutes of the Parish Council Meetings held on Wednesday 17th May 2023 at 7.30 pm

36.23. Welcome, Public Session and Partner updates.

The Chairman welcomed everyone to the Parish Council meeting. Flying Officer Joshua Chrich updated the Parish Council on night flying, noise complaints and support for the Cosford Airshow. The Station is also providing looking at the possibilities of static displays of helicopters at the Tern Valley Show in Stoke on Tern. Councillor Paul Gill updated the meeting in terms of providing support to Parish Councils during the year. Highlighting the improvements through 'fix my street' and key campaigns around road safety on the A41, the real pressures on Shropshire Councils budget this year, the boundary review and local plan .There being no further items the Chairman thanked Flying Officer Joshua Chrich and Shropshire Councillor Paul Gill for their updates and moved onto the next item of business as no Parishioners were present.

42.23. To approve the minutes of the meetings of the 15th March 2023.

Cllr K Newby moved and Cllr R Wright seconded the minutes of the meetings held on the 15th March 2023 and these were unanimously agreed and signed by the Chairman in the presence of members.

43.23. Clerk 's Report.

The Clerk updated members on a series of projects and suggested initiatives. Cllr Mrs L Bearman has agreed to take the lead role in terms of wild flower planting/seeding at the Millennium/Glebe field and Cemetery. Members agreed the following actions from the report. That a potential project involving an oak seat and willow canopy be developed as part of a Tesco grant application at cemetery site. An approach be made to Shropshire Council to broker a land transfer to the Parish Council for a peppercorn of the public realm land at Dutton Close from the developer, this will enable investment into the play park using local CIL and for the Residents Association to continue to manage the site if agreed. That the whole of the 25k of Community Benefit from the Solar Farm Company be spend on highway and environmental infrastructure within Eaton upon Tern. In terms of Mill Lane (part) in Eaton upon Tern an Expression of Interest (EOI) for re-surfacing be submitted for local CIL funding, and that other local organisations be approached about investing in their community infrastructure as part of an EOI focused on health/sport. Members further agreed that the Cemetery be re-designated as a 'hybrid' site to accommodate natural/green burials.

44.23. Update on potential changes to the land registry document for Stoke on Tern Parish Hall.

As both sides have agreed the amended wording for a re-submission to the Land Registry, the only outstanding item to resolve is around value. Members agreed to seek independent legal advise on the subject of value within a re-submitted registration in due course, the meeting was also advised that the Management Committee of the Parish Hall would seek advise concurrently. It was agreed to await feed back from the Parish Hall first.

45.23. Actions from the Parish meeting held on the 10/05/23.

Following the Parish meeting held on the 10/05/23 to discuss speeding on Rosehill Road and through Wistanswick. The Police who attended the meeting agreed to research and evaluate with the Safety Road Partnership the two different units of equipment suggested for use on the sites and report back in due course. New information also came forward at the meeting in terms of a 20 mph zone around Stoke on Tern Primary School, this information could have a bearing on the suggested systems under review. Members agreed to a 'Stop Press' within the newsletter informing Parishioners of all these developments.

46.23. Cemetery Developments.

Members agreed that the working party would clear and maintain the lay-by on the opposite side of the road to the cemetery and that a bin be purchased from Shropshire Council and located on the verge adjacent to the lay-by.

47.23. Ollerton Pound.

Cllr K Newby indicated that little progress had been made via Shropshire Council to engage with the landowner of the pound. The next possible point of call is with English Heritage for advise due to the listed nature of the structure.

48.23. Newsletter.

Cllr Mrs S Bartram thanked all those involved in anticipation of the newsletter delivery.

49.23. Planning Committee reports.

The March 2023 minutes of the Planning Committee had already been circulated and agreed for inclusion in the final PDF of the minutes to be placed on the web site from this meeting. The planning protocol was agreed by members, the protocol would also be discussed with Planning Officers at Shropshire Council. The following applications were also discussed with **No Objections** raised for. 23/01701/FUL – 1, Rosehill Road, 23/01825/HHE Tern House, Eaton upon Tern and 23/01868/FUL Pumping Station Stoke on Tern.

50.23. <u>Highways.</u>

A41: The campaign group are still waiting for an update in terms of funding from the Police Crime Commissioner for a number plate identification camera on the A41. Cllr Mrs S Planton raised the need for a grit bin on Rosehill Road, members agreed to forward this request to Shropshire Council.

51.23. Financial matters.
