17.21 Welcome and Public Session.

The Chairman welcomed members and partners to the Parish Council Zoom meeting. Flight Sergeant Wood from RAF Shawbury reported to members that No.1 Flying Training School will be night flying as from Monday 15th March 2021 for approximately six weeks. The Chairman, who attends the Helicopter Liaison Group also reported a huge drop in complaints and that the glider school would be training again from next month. Many of the course students use the new simulators at the Station for their training plans which reduces the need for actual flying. The Flight Sergeant also highlighted that community projects would start again in a gradual way once it is deemed safe by the RAF post pandemic. There being no other Partners or Parishioners present the Chairman thanked Flight Sergeant Danny Wood for his update and moved to the next item of business.

19.21. To approve the minutes of the meeting of the 20/01/21.

Cllr K Newby proposed and Cllr R Wright seconded the minutes of the 20/01/21 and were unanimously agreed and signed by the Chairman who would post a signed copy to the Clerk.

20.21. Clerk Report.

The following items were raised from the report.

i. Action by others: Cllr Rob Gittins has been asked to brief the new Shropshire Councillor on potholes, gullies and flooding after the elections.

ii. Dutton Close Residents Association has recently completed their annual ROSPA inspection of the play park. Members agreed that the Clerk seek additional clarity in terms of the equipment repairs and report back. Members further agreed that

attempts be made to contact the land owners with reference to the land lease so that the CIL grant application could proceed.

iii. Community led Housing: Recruitment of six Parishioners has been successful for involvement in the next stage of the group and an online meeting would be

organised for May 2021.

- iv. Glebe field: Members received an update on the proposal for a hard surface at the Glebe field to accommodate the use of vehicles as highlighted within the lease. The proposal of road planings as the base for vehicle movements on the site was not acceptable because of potential cross contamination. Members agreed that Cllr K Newby be given authority to negotiate an acceptable scheme on the site.
- v. A41 defibrillator: Members agreed to continue the development of the location and purchase of a defibrillator to be housed in the bus shelter at Riverside Drive on the junction of the A41.
- vi. Internal Auditor: Members agreed that the services of Derrick Moore be used again for internal auditing for 20/21
- vii. An update was given to Members on the recent paperwork circulated for the 6th May 2021 Local Elections.

21.21. Ollerton Pound.

Agreement has been reached between the owner and Shropshire Council that Cllr K Newby undertakes to systemically remove and destroy the invasive ivy on the structure of the pound. The access gate keys for the site are awaited.

22.21. Old Tip at Wistanswick. Nothing further to report.

23.21. Old Pump House Wistanswick.

Contact has been made with Severn Trent's property management who are assessing the site in terms of a potential lease for community use.

24.21. Newsletter

Cllr Mrs S Bartram asked members for any articles for the next newsletter for printing and delivery in April 2021.

25.21. Task Force update Clive Barracks, Tern Hill. Nothing further to report.

26.21. Neighbourhood Plan update.

The Parish Council received an update on the final stages of the Neighbourhood Plan process. The delayed Referendum would take place on Thursday 6th May 2021 and two leaflets were agreed for distribution, subject to some minor amendments, during April and May to encourage Parishioners to vote YES for the Plan.

27.21. Street Lighting Dutton Close.

A second leaflet has been circulated around Dutton Close informing Parishioners of the outcome of the consultation for new street lights. Attached to the rear of the leaflet is a map indicating the twelve locations agreed by the Parish Council at their last meeting. The next stages are to await any feedback on the locations and to progress, once the technical responses have been received with a CIL local Expression of Interest application (EOI) to the value of twenty five thousand pounds inclusive of VAT.
