39.20. Disclosures of Personal and Prejudicial Interest: None.


40.20. To approve the minutes of the meeting held on the 15th March 2020.

in early August 2020

1. Attendance online

2. Apologies

Apologies were received from K Beardmore who is on holiday.

3. Declaration of Interest

K Newby declared an interest from one Application and did not participate in that decision.

4. Matters Considered

- 1. <u>20/02558/FUL- The Spinney, Ollerton</u> **Object.** Following a site inspection the Parish Council wish to object to this Application on Heritage grounds. However the Council do not object to the principle of the development but feel it could be more sensitively handled. The heritage value of the two buildings has been reduced over time particularly since the construction of the brick wall across the former access which severs the properties from their original setting. The Council feel that should the Applicant be prepared to delineate the separate structures by building/cladding the proposed link building in timber this would help preserve the heritage value whilst allowing the property to function well as a residential property.
- 2. <u>20/02725/FUL Proposed Agricultural Building</u> **No Objection** However, given that the Applicant is a builder by profession and already has commercial property in the area the Parish Council would wish to see a Condition imposed that the building can <u>only</u> be used for Agricultural purposes should Planning Permission be granted.
- 3. <u>20/02727/FUL Residential Development on Rosehill Road</u> **Object.** The Parish Council wish to maintain their objection to this Application on the grounds of the scale and orientation of the proposed development. However following a site meeting with the Applicant on 6th August, we understand that a further revision to this Application is likely to be forthcoming which may address a number of our concerns, and we look forward to seeing these changes.

4.20/02737/REM - Lilac Cottage, Rosehill Road - No Objection as the County Council has approved this location in principle the Parish Council accepts that this is an appropriate scale of development for this plot.

- 4. Matters Considered
 - 1. <u>20/02287/REM Land at Dutton Close</u> Object. The Parish Council wish to maintain their objection to this development on the grounds that the proposed house is still large for the plot and as it is proposed to be fully rendered will not be in keeping with the other houses on the estate which are brick clad on the ground floor.
 - 2. 20/02727/FUL Residential Development on Rosehill Road Object. The Parish Council wish to maintain their objection to this Application on the grounds that whilst it is recognised that some changes to the scheme have improved the appearance of the proposed dwelling it is still too large, both in terms of its footprint and its height, and is not therefore in keeping with its surroundings. As a point of information the only other two storey dwelling near the proposed house on Rosehill Road has a substantially smaller footprint and has a lower ridgeline at approximately 6.5m, all the other properties are single storey.
